President Umane called the meeting to order at 11:20 A.M.

Commissioner Sipp requested to discuss a Staten Island personnel matter in Executive session.

Secretary Dent reported that in October 2007 she requested and received Board approval, pursuant to §2604(e) of the New York City Charter, to serve as Executive Director of the Audrey Johnson Day Care Center, sponsored by the Bushwick Community Action Association, Inc., a tax-exempt non-profit providing educational services and programs for children, while serving as Commissioner of Elections. That determination was filed with the NYC Conflicts of Interest Board. In the interest of full disclosure, Secretary Dent noted the following for the record:

"In the fiscal year beginning July 1, 2009, my organization has been allocated \$20,000 in City tax-levy funds through the New York City Council for program enhancements. An additional \$20,000 has been allocated in New York State Funds to the Bushwick Community Action Association, Inc. by the New York State Senate for additional program enhancements that benefit the children served by the Audrey Johnson Day Care Center."

Commissioner Sipp requested an advance of an additional 210 hours of sick leave for Lloyd Bacchus, a Voting Machine Technician in the Staten Island Office. Commissioner Sampel seconded the motion, which was adopted unanimously.

President Umane convened an Executive Session.

Following the Executive Session, the open public session resumed and President Umane reported that no action was taken in Executive Session.

President Umane moved to adjourn the meeting. Commissioner Araujo seconded the motion, which was adopted unanimously.
