President Polanco called the meeting to order at 10:08 A.M. Mr. Richman noted that a quorum was present.

President Polanco welcomed and congratulated the newly appointed Richmond County Democratic Commissioner Maria R. Guastella. He

stated that the Commissioners look forward to working with her at the Board.

President Polanco announced that the Commissioners would conduct the Hearings relating to Designating Petition Matters for the September 13, 2011 Primary Election.

President Polanco announced the procedures to be followed during the hearings.

President Polanco requested that at future hearings the documents that are submitted to the Commissioners for review be numbered.

Mr. Richman reported that in accordance with the Commissioners' direction, notice was given to all interested and necessary parties concerning today's Public Hearings to consider the Board's staff Preliminary Findings of Prima Facie Defects, Candidate Enrollment Issues, as well as Specifications of Objections and other concerns relating to the September 13, 2011 Primary Elections.

Mr. Richman called for the Hearings on Bronx County Prima Facie

matters.

Mr. Johnson called the Candidate Enrollment Issues Report for Bronx County. There were no appearances. President Polanco moved to adopt the Candidate Enrollment Issues Report for Bronx County. Commissioner Umane seconded the motion, which was adopted unanimously.

Mr. Richman called for the Hearings for Richmond County

Prima Facie matters.

Mr. Johnson called the Candidate Enrollment Issues Report for Richmond County. Commissioner Sipp moved to adopt the Candidate Enrollment Issues Report for Richmond County as amended. Commissioner Guastella seconded the motion, which was adopted unanimously.

Mr. Johnson called the CRU Prima Facie Report for Richmond County. There were no appearances. Commissioner Sipp moved to adopt the CRU Prima Facie Report for Richmond County. Commissioner Guastella seconded the motion, which was adopted unanimously.

Mr. Richman presented the Counsel Report on Specification of Objections RH 6-1 and RH 7-1. Commissioner Sipp moved to adopt the Counsel Report. Commissioner Umane seconded the motion, which was adopted unanimously.

In selected instances, there were appearances by candidates or their representative which are noted on the Clerk's Reports on file at the Board. The Commissioners' determinations are reflected on each Clerk's Report acted upon. Selected Richmond County Clerk's Reports on Specification of Objections were postponed until Wednesday, August 3, 2011 at 1:00 P.M.

Mr. Richman called for the Hearings on Kings County Prima Facie matters.

Mr. Johnson called the Democratic Candidate Enrollment Issue Report for Kings County. Ms. Brown called the Republican Candidate Enrollment Issue Report. Commissioner Schacher moved to adopt the Candidate Enrollment Issue Report for Kings County as amended. Commissioner Dent seconded the motion, which was adopted

unanimously.

Mr. Graves called the CRU Prima Facie Report for Kings County. Secretary Soumas moved to approve the CRU Prima Facie Report for Kings County as amended. Commissioner Umane seconded the motion, which was adopted unanimously.

Mr. Richman called the Kings County Clerk's Reports on Specification of Objections. In selected instances, there were appearances by candidates or their representative which are noted on the Clerk's Reports on file at the Board. The Commissioners' determinations are reflected on each Clerk's Report acted upon.

Commissioner Schacher thanked the Brooklyn Office staff for their hard work and for submitting excellent reports.

President Polanco recessed the Hearings. He announced that the Hearings on Designating Petitions related to the September 13, 2011 Primary Election will continue after the scheduled break at 12:00 Noon. He stated that they will resume following the Commissioners' Meeting and to be present at 12:45 P.M.

The stated meeting of the Commissioners convened at 12:45 P.M.

Commissioner Dent moved to approve the minutes of the July 20, 2011 meeting. Commissioner Schacher seconded the motion. In a roll call vote, there were six (6) in favor (Araujo, Dent, Polanco, Schacher, Sipp, Stupp) and three (3) abstentions (Guastella, Soumas, Umane). The motion was adopted.

Mr. Johnson reported that a public random drawing for the order of the ballot for the 2011 Primary Election is scheduled for August 4, 2011 at 10:00 A.M. in the Executive Office. He stated that the Candidate Records Unit (CRU) staff sent notice to the candidates and their contact person. In addition, the public notice is posted on the Board's website. Commissioner Umane moved to designate the CRU staff on a bi-partisan basis to conduct the random drawing for the order of the ballot for the 2011 Primary Election. Commissioner Stupp seconded the motion, which was adopted unanimously.

Commissioner Umane requested to add a Manhattan personnel matter to the agenda.

Mr. Richman requested to add an item to the agenda. He asked the Commissioners to designate a Cover Sheet Review Committee for the amended Cover Sheets for Opportunity to Ballot (OTB) Petitions. The Commissioners designated Secretary Soumas and Commissioner Umane.

Mr. Ward presented the Vacancy Report dated August 2, 2011. A copy of his report is in the agenda.

President Polanco inquired if the Board has received any additional resumes as it relates to the position of Executive Director. Ms. Delayo replied no.

President Dent reported that there is a grammatical error on page 5 in the approved Commissioners' Meeting Minutes for July 20, 2011. President Polanco moved to adopt the minutes as corrected by Commissioner Dent. Commissioner Araujo seconded the motion, which was adopted unanimously.

President Polanco moved to convene an Executive Session to discuss personnel matters. Commissioner Araujo seconded the motion, which was adopted unanimously.

Following the Executive Session, the open public meeting resumed and President Polanco reported on the following actions taken in Executive Session:

- I. The Commissioners granted an advance of two (2) weeks of sick leave time to Charlette Jordan, a Clerk in the Manhattan Borough Office, effective August 1, 2011.
- II. The Manhattan Borough Office will receive sixteen (16) new Temporary Clerks, effective immediately until the certification of the 2011 General Election.
- III. The Commissioners agreed to hire two (2) Temporary Clerks to assist with the Chinese translation projects in the Executive Office, effective immediately until the certification of the 2011 General Election.

Commissioner Umane moved to adjourn the stated meeting.

Commissioner Araujo seconded the motion, which was adopted unanimously.

The next stated meeting of the Commissioners is scheduled for Tuesday, August 9, 2011 at 1:30 P.M. It was noted that the OTB Hearings will be held prior to the stated meeting.

President Polanco announced that the Commissioners would resume the Hearings relating to Designating Petition Matters for the September 13, 2011 Primary Election.

President Polanco announced the procedures to be followed during the Hearings, again.

Mr. Richman called for the Hearings for Queens County Prima Facie matters.

Commissioner Stupp thanked the Queens Office staff for their hard work.

Commissioner Umane moved to authorize the printing of the Military and Absentee ballots based on the determinations made today so that the Board can meet the requirements of the law. Secretary Soumas seconded the motion, which was adopted unanimously.

Commissioner Umane moved to adjourn the Hearings on Challenges relating to Designating Petition Matters for the September 13, 2011 Primary Election until tomorrow at 1:00 P.M. The motion was adopted unanimously.
