Commissioner Araujo moved to adopt the Counsel's Report on Queens County. Commissioner Stupp seconded the motion, which was unanimously adopted.

Mr. Johnson presented the CRU Prima Facie Report for Queens County. In selected instances, there were appearances by candidates and/or their representatives which are noted on the CRU Prima Facie

Report on file at the Board. Commissioner Araujo moved to adopt the CRU Prima Facie Report regarding Specification 137. Commissioner which Stupp seconded the motion. was unanimously adopted. Commissioner Araujo moved to adopt the CRU Prima Facie Report regarding Declination QN 313. Commissioner Schacher seconded the motion, which was unanimously adopted. Commissioner Araujo moved to adopt the report as amended. Commissioner Stupp seconded the motion, which was unanimously adopted.

President Guastella noted that Commissioners Schacher, Dent and Polanco joined the meeting.

Mr. Denkberg presented the Queens County Clerk's Reports on Specifications of Objections. In selected instances, there were appearances by candidates and/or their representatives which are noted on the Clerk's Reports on file at the Board. Commissioner Stupp recused herself from consideration of Specification of Objections Nos. QN106-1, QN114-1, QN114-2, and QN114-3. The Commissioners' determinations are reflected on each Clerk's Report acted upon.

The Commissioners recessed the Hearings for thirty (30) minutes.

After recess, President Guastella reconvened the Hearings and stated the procedures to be followed during the Hearings.

President Guastella noted that Commissioner Soumas joined the meeting.

Mr. Richman called for the Hearings on Kings County Prima Facie matters.

Mr. Savino presented the Counsel's Report on Kings County. There were no appearances. Commissioner Schacher moved to adopt the Counsel's Report. Commissioner Dent seconded the motion, which was unanimously adopted.

Mr. Johnson presented the CRU Prima Facie Report for Kings County. There were no appearances. Commissioner Schacher moved to adopt the report. Commissioner Schacher seconded the motion, which was unanimously adopted.

Mr. Richman presented the Kings County Clerk's Reports on Specifications of Objections. In selected instances, there were appearances by candidates and/or their representatives which are noted on the Clerk's Reports on file at the Board. The Commissioners' determinations are reflected on each Clerk's Report acted upon.

It was noted that Kings County Petitions KG1202354, KG1202355 and KG1202356, the Petition of Elias J. Weir for Member of State Senate District, 19th SD, contained sheets of photocopied petitions which is a fraudulent matter. Mr. Richman stated that per past practice, these fraudulent matters are referred to the respective District Attorney's Office. Commissioner Soumas moved to refer Kings County Specification of Objections 102-1 to the New York County and Kings County District Attorney's Offices. Commissioner Schacher seconded the motion, which was unanimously adopted.

Mr. Richman presented the Counsel's Report on Specification of Objections #45. There were appearances by Frank Carone, Esq. on behalf of the Objector, and Sarah Steiner, Esq. on behalf of the Candidate. Commissioner Dent moved to adopt the Counsel's Report. Commissioner

Soumas seconded the motion, which was unanimously adopted.

Commissioners Schacher and Dent thanked the Brooklyn Office for their hard work during the petition filing cycle.

Mr. Johnson announced that he will conduct the random draw for the order of the ballots next Tuesday following the Commissioners' Meeting. A public notice will be posted on the Board's website and at the Front Counters.

Secretary Umane moved to direct Mr. Richman to request that the New York City Law Department represent the Commissioners in the Ognibene v. BOE action in Federal Court. Commissioner Araujo seconded the motion, which was unanimously adopted.

President Guastella moved to adjourn the Hearings. Secretary Umane seconded the motion, which was adopted unanimously.
