Commissioner Araujo moved to post the Schedule of Hearings on the Board's website. President Michel seconded the motion, which was unanimously adopted.

Mr. Richman reported that the Board received two (2) Orders to Show Cause, but they contained provisions that were not in accordance with the Board's adopted Designating Petition Rules, specifically Rule K, relating to the production of documents and records in judicial proceedings. requested to ask the New York City Law Department to negotiate with the opposing counsels to see if they will modify their Orders to conform to the Board's Rule and if not, to seek the necessary stay to produce documents in the Appellate Division under the civil practice law. Commissioner Umane provided background information about Rule K. Commissioner Castorina recommended taking the necessary steps to protect the integrity of the Board's Rules. Commissioner Umane moved to authorize Corporation Counsel to take appropriate steps to preserve the Board's Rules and to limit the amount of information that is required on the opening day, and to hope and expect that at any Hearings that require the full provision of records to be done at the local Board Offices rather than at the court houses, and only such information that is specifically directed by the court have to be brought to the court house. Commissioner Castorina seconded the motion, which was unanimously adopted.

Mr. Richman reminded that the Commissioners' Petition and Cover Sheet Review Committee will be meeting immediately after the meeting.

Secretary Perez noted that Commissioner Flateau is present.

Secretary Perez moved to adjourn the meeting. Commissioner Araujo seconded the motion, which was unanimously adopted.
