Secretary Umane called the meeting to order at 10:00 A.M.

Secretary Umane announced that the Commissioners will conduct the continuation of Hearings on challenges to designating petitions for State and Local Offices as well as Party Positions to be contested in the September 13, 2016 Primary Election.

Secretary Umane stated the procedures to be followed during the Hearings and called upon Mr. Richman to call the Calendar for the Hearings.

Mr. Richman called the Calendar for the Hearings on Designating Petition matters for Richmond County. The Calendar was posted for the public as required.

Mr. Schlein submitted an obituary for Dr. Roscoe C. Brown Jr. After discussion, Secretary Umane moved voter status deceased for to change the to Dr. Roscoe C. Brown. In a roll call vote, with six (6) in favor (Araujo, Flateau, Schulkin, Shamoun, Umane, Vargas) and three (3) opposing (Grey, Michel, Rendino), the motion was adopted. Commissioner Grey noted that she opposed because the Board requires a Death Certificate

and does not want to set a precedent to accept obituaries in the future. Commissioner Vargas noted that she voted in favor for this case only due to Commissioner Flateau's personal knowledge of the deceased. The Commissioners urged Mr. Schlein to obtain and submit a Death Certificate to the Board as soon as possible. Commissioner Flateau moved to adopt the Certificate of Substitution. Commissioner Araujo seconded the motion. In a roll call vote, with seven (7) in favor (Araujo, Flateau, Michel, Schulkin, Shamoun, Umane, Vargas) and two (2) opposing (Grey, Rendino), the motion was adopted.

In selected instances, there were appearances by a candidate and/or their representative which is noted on the Candidate Enrollment Issues Report on file at the Board. Specifications of Objections Nos. BX-71 and KG-111 were placed on the Calendar for Friday, August 5, 2016 at 11:00 A.M. Commissioner Araujo and Commissioner Michel will serve as the Commissioners' Committee to act on both matters on behalf of the Board. With respect to Specifications of Objections No. KG-111, candidate George Tsikhiseli and objector Joshua Ehrlich both agreed to waive the 24 Hour Rule, and to reconvene and review the submitted List of Exceptions with two (2) clerks tonight and/or tomorrow in the Brooklyn Office, and to return on Friday, August 5, 2016 at 11:00 A.M. to present their findings.

Secretary Umane moved to adjourn the Hearings. The motion was seconded, and unanimously adopted.
