President Umane called the meeting to order at 1:34 P.M.

Commissioner Schulkin moved to adopt the minutes for the June 6, 2017 meeting. Commissioner Siano seconded the motion, with Commissioners Araujo and Vargas abstaining. The motion was adopted. President Umane added an Executive Session for purposes of personnel.

President Umane recognized Rosemarie Hameed, a member of the public, who inquired about running for public office.

Commissioner Michel moved to convene an Executive Session for purposes of personnel. Commissioner Zaccone seconded the motion, which was unanimously adopted.

Following Executive Session, the open public meeting resumed and Mr. Ryan reported the following actions that were taken in Executive Session:

- The Commissioners approved a merit raise of \$2,600 annually to Joseph Citron, an Administrative Associative in the Queens Office. Commissioner Michel recused himself from this matter and was not present in the room for the discussion;
- II. The Commissioners granted 128 hours Advance of Time to Sheryl Logan, an Administrative Assistant in the Manhattan Office. Ms. Logan's agency start date is March 26, 2006;

- III. The Commissioners granted 14 hours Advance of Time to Raquel Torres, a Voting Machine Technician in the General Office, retroactive to June 6, 2017. Ms. Torres' agency start date is March 11, 2012. Commissioner Araujo recused himself from this matter;
- IV. The Commissioners approved the distribution of \$20,000, per Commissioner, in merit money for staff on an annualized basis;
- V. The Commissioners approved an offer of employment to Irene Cheung to serve as the Democratic Chinese Interpreter with an annual salary of \$44,855. The extension of employment is effective immediately.

President Umane moved to adjourn the meeting. The motion was seconded and unanimously adopted.
