Pursuant to the provisions of Title 2 of Article 9 of the New York State Election Law, specifically Section 9-204, Secretary Zaccone convened the meeting of the Board of Canvassers in the City of New York for the purposes of certifying the recanvass of votes cast on June 26, 2018 in the Democratic, Republican, Conservative, and Reform Parties Federal Office Primary Elections in the City of New York.

Secretary Zaccone designated the Republican Commissioner for the respective counties and Commissioner Michel to serve with him for the Richmond County Statement and Return of Canvass as well as the multi-county recaps. Commissioner Flateau, the ranking Democratic Commissioner present, designated the Democratic Commissioners for the respective counties who are present and Commissioner Schulkin to serve with him for Richmond, Bronx, and Queens Counties and the multi-county recaps.

The Deputy Chief Clerks of the Bronx and their staff have prepared and signed the Return of Canvass for the Democratic and Reform Party Federal Office Primary Elections conducted in Bronx County on June 26, 2018. Ms. Candelaria and Mr. Cirotti, on behalf of Mr. Ribustello, presented them to the Canvassing Board for review and approval.

Ms. Candelaria and Mr. Cirotti confirmed that the results presented are accurate and correct, there are no discrepancies, and the audit of voter verifiable audit records for both the poll site and central count scanners required by Section 9-211 of the New York State Election Law has been successfully completed. Based on that report, Commissioner Siano moved that the Board of Canvassers certify the Return of Canvass for the Democratic and Reform Party Federal Office Primary Elections conducted in Bronx County on June 26, 2018. Commissioner Michel seconded the motion, which was unanimously adopted.

The Chief Clerk and Deputy Chief Clerk of Brooklyn and their staff have prepared and signed the Return of Canvass for the Democratic, Republican, Conservative, and Reform Party Federal Office Primary Elections conducted in Kings County on June 26, 2018. Mr. Ortiz and Mr. Riley presented them to the Canvassing Board for review and approval. Mr. Ortiz and Mr. Riley confirmed that the results presented are accurate and correct, there are no discrepancies, and the audit of voter verifiable audit records for both the poll site and central count scanners required by Section 9-211 of the New York State Election Law has been successfully completed. Based on that report, Commissioner Flateau moved that the Board of Canvassers certify the Return of Canvass for the Democratic,

Republican, Conservative, and Reform Party Federal Office Primary Elections conducted in Kings County on June 26, 2018. Commissioner Shamoun seconded the motion, which was unanimously adopted.

The Chief Clerk and Deputy Chief Clerk of Manhattan and their staff have prepared and signed the Return of Canvass for the Democratic and Federal Office Elections Reform Party Primary conducted New York County on June 26, 2018. Mr. Lehman and Ms. Doty presented them to the Canvassing Board for review and approval. Mr. Lehman and Ms. Doty confirmed that the results presented are accurate and correct. There was one (1) discrepancy which did not change the outcome of the results. The Discrepancy Report is attached to the Return of Canvass. Mr. Lehman and Ms. Doty confirmed that the audit of voter verifiable audit records for both the poll site and central count scanners required by Section 9-211 of the New York State Election Law has been successfully completed. Based on that report, Commissioner Schulkin moved that the Board of Canvassers certify the Return of Canvass for the Democratic and Federal Office Primary Elections Reform Party conducted New York County on June 26, 2018. Commissioner Shamoun seconded the motion, which was unanimously adopted.

The Chief Clerk and Deputy Chief Clerk of Queens and their staff have prepared and signed the Return of Canvass for the Democratic and Reform Federal Office Elections Party Primary conducted Queens County on June 26, 2018. Ms. Berinato and Ms. Cicio, on behalf of Mr. Haggerty, presented them to the Canvassing Board for review and approval. Ms. Berinato and Ms. Cicio confirmed that the results presented are accurate and correct, there were no discrepancies, and that the audit of voter verifiable audit records for both the poll site and central count scanners required by Section 9-211 of the New York State Election Law has been successfully completed. Based on that report, Commissioner Michel moved that the Board of Canvassers certify the Return of Canvass for the Democratic and Reform Party Federal Office Primary Elections conducted in Queens County on June 26, 2018. Commissioner Flateau seconded the motion, which was unanimously adopted.

The Chief Clerk and Deputy Chief Clerk of Staten Island and their staff have prepared and signed the Return of Canvass for the Democratic, Republican, Conservative, and Reform Party Federal Office Primary Elections conducted in Richmond County on June 26, 2018. Mr. Bosco and Mr. Andriulli presented them to the Canvassing Board for review and approval. Mr. Bosco and Mr. Andriulli confirmed that the results presented

are accurate and correct. There was one (1) discrepancy which did not change the outcome of the results. The Discrepancy Report is attached to the Return of Canvass. Mr. Bosco and Mr. Andriulli confirmed that the audit of voter verifiable audit records for both the poll site and central count scanners required by Section 9-211 of the New York State Election Law has been successfully completed. Based on that report, Commissioner Siano moved that the Board of Canvassers certify the Return of Canvass for the Democratic, Republican, Conservative, and Reform Party Federal Office Primary Elections conducted in Richmond County on June 26, 2018. Commissioner Flateau seconded the motion, which was unanimously adopted.

Commissioner Flateau moved to approve and adopt the Recap Statement and Return of Canvass for the Democratic, Republican, Conservative, and Reform Party Federal Office Primary Elections conducted on June 26, 2018 for those Congressional Districts which cross county lines within the City of New York. Commissioner Schulkin seconded the motion, which was unanimously adopted.

Commissioner Schulkin moved to electronically affix the appropriate Commissioners' signatures as previously designated on each Statement and Return of Canvass. Commissioner Flateau seconded the motion, which was unanimously adopted.

Commissioner Flateau moved to adjourn the Meeting of the Board of Canvassers and to convene the weekly stated meeting of the Commissioners of Elections in the City of New York. Commissioner Shamoun seconded the motion, which was unanimously adopted.

Commissioner Siano moved to adopt the minutes for the June 19, 2018 meeting. Commissioner Michel seconded the motion, which was unanimously adopted.

Mr. Richman requested for the appointment of Commissioners' Cover Sheet Review Committees for Week #1 for Designating Petitions filed for the September 13, 2018 Primary Election. The designated schedule follows:

Commissioner Schulkin noted that President Vargas expressed interest in serving on the Commissioners' Cover Sheet Review Committee.

Mr. Richman presented the Draft Filing Calendar for Independent Nominating Petitions for the November 6, 2018 General Election. Copies of the draft calendar were circulated to the Commissioners for review. Mr. Richman recommended convening the hearings on Thursday, September 6, 2018 at 1:30 P.M. Commissioner Michel moved to adopt the Independent Filing Nominating Calendar for **Petitions** for the November 6, 2018 General Election as submitted. Commissioner Siano seconded the motion, which was unanimously adopted.

Commissioner Schulkin moved to convene an Executive Session for personnel matters. Commissioner Michel seconded the motion, which was unanimously adopted.

Following Executive Session, the open public meeting resumed and Mr. Ryan reported the following actions that were taken in Executive Session:

- I. From a prior meeting held on June 27, 2018, it was recommended by the Hearing Committee to terminate the employment of Michael Motta, a Manhattan Democrat, after a Disciplinary Hearing. This action was approved by a Board of Commissioners at a Special Meeting held on June 27, 2018 at 2:15 P.M. Public announcement of the termination was deferred to provide notification to Mr. Motta. Notification has been completed;
- II. The Commissioners granted 175 hours Advance of Time to Brittany Caicedo, an Administrative Assistant in the Queens Office, retroactive to July 9, 2018. Ms. Caceido's agency start date is March 29, 2015.

Secretary Zaccone moved to adjourn the meeting.

The motion was seconded, and unanimously adopted.
