President Zaccone reported that Executive Management and staff are engaged at the New York City Council Hearing and are expected to arrive shortly.

President Zaccone moved to convene an Executive Session for personnel and litigation matters. Commissioner Umane seconded the motion, which was unanimously adopted.

Following Executive Session, the open public meeting resumed and President Zaccone reported that there was a report on litigation and no action was taken. Action was taken on one (1) personnel matter which will be reported at a later date.

The following personnel action was taken by the unanimous decision of the Board of Commissioners in Executive Session on April 30, 2019:

I. Norma Saunders, a Trainer Assistant, was granted 140 hours of an Advance of Time. This grant is effective April 18, 2019.

President Zaccone noted that Mr. Ryan, Ms. Sandow, Ms. Perkins, Ms. Kontzamanis, Mr. Richman, Mr. Savino and Ms. Vazquez have joined the meeting.

Mr. Ryan reported on the designation of Early Voting poll sites and related matters for the November 5, 2019 General Election. Mr. Richman recalled that the New York State Legislature and Governor enacted into law Early Voting provisions and Chapter 6 of the Laws of 2019. According to the law, the Board must designate Early Voting poll sites on or before May 1st for the November 5, 2019 General Election as well as the voting hours within the statutory timeframe during the Early Voting period, and to determine if Early Voting will be on a regional or countywide basis.

President Zaccone recommended Early Voting on a regional basis due to the voting equipment, materials and established procedures that are currently available at the Board. President Zaccone moved to adopt Early Voting on a regional basis, designating specific Election Districts to specific poll sites, for the November 5, 2019 General Election. Commissioner Umane seconded the motion, which was unanimously adopted. Mr. Ryan recommended the following hours of operation schedule for the Early Voting period for the November 5, 2019 General Election, which exceeds the statutory requirement:

- <u>Weekends</u>
 - 10:00 A.M. to 4:00 P.M.
 - Saturday, October 26, 2019
 - Sunday, October 27, 2019
 - Saturday, November 2, 2019
 - Sunday, November 3, 2019
- <u>Weekdays</u> (Polls are required to open early at least 1 day and polls are required to be open late at least 2 days)
 - 9:00 A.M. to 5:00 P.M.
 - Monday, October 28, 2019
 - Tuesday, October 29, 2019
 - Wednesday, October 30, 2019
 - o 7:00 A.M. to 8:00 P.M.
 - Thursday, October 31, 2019
 - Friday, November 1, 2019

It was noted that this proposed schedule was developed based on information received from other jurisdictions that conduct Early Voting. President Zaccone moved to adopt the recommended hours of operation schedule for the Early Voting period for the November 5, 2019 General Election as presented. Secretary Taylor seconded the motion, which was unanimously adopted. Mr. Ryan reported that staff has identified a total of 38 Early Voting poll sites to date. It was noted that this preliminary list of poll sites is a foundation and a work in progress. Mr. Ryan recommended for the Commissioners to designate the following Early Voting poll sites for the November 5, 2019 General Election:

Mr. Ryan noted that this preliminary list exceeds the statutory minimum and can be extended at a later date. The list of Early Voting poll sites will be sent to the New York State Board of Elections and will be posted on the Board's website for the public. Secretary Taylor moved to designate the Early Voting poll sites for the November 5, 2019 General Election as presented. Commissioner Umane seconded the motion, which was unanimously adopted.

For informational purposes, Mr. Ryan reported that he forwarded an email to the Commissioners on April 25, 2019 regarding Local Law 238 and attached the conflicting opinions received from the New York State Board of Elections concerning the legality of Intro 508-A, now Local Law 238. This item will be on next week's Commissioners' Agenda for discussion and recommendation. In response to President Zaccone's request, Mr. Ryan provided a brief overview of the matter. Intro 508-A became Local Law 238 in December 2017 regarding the establishment of the New York City Campaign Finance Board (CFB) as an entity to establish an online voter registration portal allowing for electronic signatures. Prior to the passage of Intro 508-A, the City Board sent a letter to the State Board in December 2017 and received conflicting opinions of the legality of Intro 508-A (Local Law 238). In January 2019, the Board received a letter from the CFB. The City Board sent a subsequent letter to the State Board in March 2019 for clarification and again received conflicting opinions of the legality of Intro 508-A (Local Law 238). The projected implementation date of CFB's online portal is scheduled for June 16, 2019 and the City Board has to make a determination of how to proceed.

President Zaccone recognized Jarret Berg, a representative of Vote Early New York, who spoke about collaborating with the Board on the implementation of Early Voting.

Commissioner Araujo moved to adjourn the meeting. Commissioner Townsend seconded the motion, which was unanimously adopted.
