First day to circulate OTB Petitions.....Tuesday, March 19, 2024
Last day to file OTB Petitions.....Thursday, April 11, 2024
Last day to file Certificate of Acceptance.....Monday, April 15, 2024
Last day to file OTB petition if a designated candidate declines.....Thursday, April 18, 2024
Last day to file General Objections.....(3) days after petition is filed
Last day to file Specifications.....(6) days after General Objection is filed

Last day to institute Judicial Proceedings.....(14) Days after last day to file petitions **OR**
(3) business days after BOE hearing where designating petition/candidacy is invalidated.
