Last day to institute Judicial Proceedings..... (14) days after last day to file petitions **OR** (3) business days after BOE hearing where petition/candidacy is invalidated.

Hearings on Independent Nominating Petitions will be held on:  
**Tuesday, June 10, 2025 - TENTATIVE**
