OPPORTUNITY TO BALLOT (OTB) PETITIONS

First day to circulate OTB Petitions.....Tuesday, March 18, 2025
Last day to file OTB Petitions.....Thursday, April 10, 2025
Last day to file OTB petition if a designated candidate declines.....Thursday, April 17, 2025
Last day to file Certificate of Acceptance.....(4) days after last day to file OTB Petition
Last day to file General Objections.....(3) days after petition is filed
Last day to file Specifications.....(6) days after General Objection is filed

Last day to institute Judicial Proceedings..... (14) days after last day to file petitions **OR** (3) business days after BOE hearing where petition/candidacy is invalidated.
