Last day to file OTB Petitions.....Thursday, April 9, 2026  
Last day to file OTB petition if a designated candidate declines.....Thursday, April 16, 2026  
Last day to file Certificate of Acceptance.....(4) days after last day to file OTB Petition  
Last day to file General Objections.....(3) days after petition is filed  
Last day to file Specifications.....(6) days after General Objection is filed  
Last day to institute Judicial Proceedings.....(14) days after last day to file petitions **OR**  
(3) business days after BOE hearing where petition/candidacy is invalidated.

Tuesday, April 28, 2026, and Wednesday, April 29, 2026  
(If needed, any additional hearings will take place on Thursday, April 30, 2026)

Only if a specified filing date for objection(s)/ specification(s)/certificate(s) is the last day to file said objection(s)/
