The Board of Elections is open for filing at 32 Broadway, 7th Floor, New York, NY 10004 from 9:00 AM to 5:00 PM. Only if a specified filing date for objection(s)/ specification(s)/certificate(s) is the last day to file said objection(s)/ specification(s)/certificate(s), will the Board of Elections remain open until Midnight.
