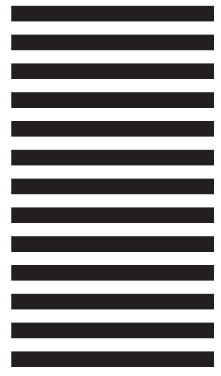

- Inspectors, Poll Clerks and Information Clerks earn a salary of \$250 for working on Election Day, \$100 for attending a training class and passing the exam.
- Interpreters and Accessibility Clerks earn a salary of \$250 for working on Election Day, \$25 for attending class and passing the exam.
- Any worker who does not attend training class and pass the exam will not be assigned to work on Election Day.
- Any worker who does not work on Election Day will not receive payment for attending class.
- Any worker who does not work at the site to which they are assigned will not be paid.
- Applicants must be willing to travel within their borough.
- Election day hours are from 5am until the poll site is closed and workers are dismissed by the Coordinator.
Early voting hours vary by day.



Board of Elections in the City of New York

Election Law Section 3-400(6)

No person shall be certified or act as an election inspector or poll clerk who is not a registered voter and a resident of the county in which he or she serves, or within the city of New York, of such city, who holds any elective public office, or who is a candidate for any public office to be voted for by the voters of the district in which he or she is to serve, or the spouse, parent, or child of such a candidate, or who is not able to speak and read the English language and write it legibly.
