Mr. Ryan opened the meeting with item #1 of the meeting agenda. President Pepe-Souvenir convened a meeting of the Board of Canvassers in the City of New York for Hearings on Independent Nominating Petitions and Related Matters for the November 5, 2024 General Election.

Following the meeting of the Board of Canvassers, the regular stated meeting of the Board of Commissioners resumed.
