

Counsel's Report on Specifications of Objection KG-30

Pursuant to the provisions of Rule I6 of the Board's Designating Petition Rules, a portion of Specifications of Objection KG-30 was referred to the Office of the General Counsel to review and report.

COUNSEL'S REPORT - SPECIFICAITONS OF OBJECTION KG 30 - APRIL 20, 2020

Attached hereto is a copy of the relevant portion of the Specifications, as Appendix 1, setting forth the claims of the objector. This report will address each one in the order submitted.

SPECIFICATION 1:

"Alleged amended cover sheet was filed at 5:26 PM after the close of business day and closure to the public at 5 PM."

Section 1-106(1) of the NYS Election Law provides in pertinent part, that for any document required to be filed the Election Law with the Board of Elections in the City of New York, it must be received by the Board on or before the last day to file and such office "shall be open for the receipt of such petitions, certificates and objections until midnight on the last day to file" any such document.

In the present instance (See discussion in Specification 2 below), April 6, 2020 was the last day to file the purported cure in response to the Notice of Non-Compliance that was mailed on April 1, 2020. Therefore, the Board was required to be open until midnight on April 6, 2020 to receive documents such as the purported cure in the form of an Amended Cover Sheet.

RECOMMENDATION:

The Office of the General Counsel recommends that the Commissioners find this Specification – **NOT AS STATED.**

SPECIFICATION 2:

"Defect Notice is dated 3/31/2020. The alleged amended Cover sheet was filed on 4/6/2020 after the 3 day deadline of 4/3/2020 as per Board of Elections Rules & Regulations"

COUNSEL'S REPORT - SPECIFICAITONS OF OBJECTION KG 30 - APRIL 20, 2020

The Commissioners' Cover Sheet and Petition Review Committee meeting was held on Tuesday, March 31, 2020 following the Stated Meeting of the Commissioners. Upon adjournment of the Committee meeting, staff prepared the appropriate Notices of Non-Compliance in accordance with the Commissioners' determinations, dated said Notices with that date of March 31, 2020 and prepared the U.S. Postal Service envelopes for priority next day delivery. Board staff then attempted to bring the sealed postage paid envelopes to the US Post Office at 90 Church Street. Upon their arrival at the Post Office after 5 PM, they called and advised that the US Post Service had implemented an emergency reduction in their operating hours with the closing time moved from 7 PM to 4 PM. Staff was directed to hold on to the postage paid envelopes and deliver the same to the US Post Office at the start of the business day on April 1, 2020.

This was memorialized in an e-mail I sent to the Executive Management, the Candidate Records Unit and my office. A copy of that email with Executive Director Ryan's acknowledgement of receipt included thereon is attached hereto as Appendix 2. Also attached hereto as Appendix 3 is a copy of the relevant page from the Board's record of petition filed with the appropriate notation in the notes column.

Based on the unforeseen emergency change in hours of operation by the U.S. Postal Service and in order to utilize the pre-paid postage envelopes and in the interests of ensuring due process, all of the Notices of Non-Compliance approved by the Commissioners Committee on March 31 and reflecting that date and actually sent on April 1, 2020 were deemed to have been made on Wednesday, April 1, 2020. Therefore, 3 business days following the mailing of the notice was Monday, April 6, 2020, the date when the purported cure was filed.

RECOMMENDATION:

The Office of the General Counsel recommends that the Commissioners find this Specification – **NOT AS STATED**.

SPECIFICATION 3:

"Two coversheets were filed. An additional "sample cover sheet" was filed on 4/6/2020 at 5:27 PM. If the Board was open after 5 pm, this coversheet supersedes the alleged amended cover sheet"

The Board's Designating Petition Rule C4 provides in relevant part that an amended cover sheet shall identify what cover sheet it is amending by "attaching a copy of the original cover sheet which it is amending or attaching a copy of the notice of non-compliance to the amended cover sheet."

In this instance, the candidate filed two cover sheets, each attached to a petition volume filed with the Board, one with petition ID # KG 2000169 on the cover sheet and the other with petition ID # KG 2000173 attached to it." The actual petition volumes had petition ID # KG 2000176 and KG 2000693 affixed to the respective volumes.

In order to comply with the Board's Rule C4, attached to the Amended Cover Sheet filed on April 6, 2020, were copies of the original two incorrect cover sheets described in the paragraph above, and cited incorrectly in this Specification. Copies attached as Appendix 4.

RECOMMENDATION:

The Office of the General Counsel recommends that the Commissioners find this Specification – **NOT AS STATED**.

SPECIFICATION 4:

"Upon information and belief, signatures in said Volume are fraudulent and each and every signatory did not identify himself to the subscribing witness."

COUNSEL'S REPORT - SPECIFICAITONS OF OBJECTION KG 30 - APRIL 20, 2020

With respect to this Specification, the Board's Designating Petition Rules provide in pertinent part:

<u>Rule H8</u> – "Objectors are warned not to include in the specifications broad, non-specific or generic claims";

<u>Rule H9 –</u> "The Board believes that the appropriate forum for determination of allegations of forgery or fraud is in an invalidating proceeding commenced in the Supreme Court pursuant to Election Law Section 16-102. ... the Board will generally decline to rule on allegations of fraud."

Under these Rules, the Board may dismiss this Specification as frivolous or decline to act on this Specification for it has no jurisdiction to rule on allegations of fraud.

RECOMMENDATION:

The Office of the General Counsel recommends that the Commissioners either:

- (a) **DISMISS** this Specification, pursuant to Rule H8; or
- (b) conclude that the Commissioners have **NO JURISDICTION** to make a determination, pursuant to Rule H9.

SPECIFICATION 5:

"The Title of Office is legally insufficient, incomplete or erroneous on every coversheet filed. In the alleged amended cover sheet the party is missing and the title is Public Office instead of Party Position; in the "Sample Cover Sheet" dated 4/6/2020 5:27 PM, the Title of Office fails to mention the Gender of the candidate.

The title of the party position on the Amended Cover Sheet is correctly stated and is legally sufficient in accordance with the provisions of the Rules of the New York State Democratic Committee and the Statement of

COUNSEL'S REPORT - SPECIFICAITONS OF OBJECTION KG 30 - APRIL 20, 2020

Party Positions filed with the Board by the Kings County Democratic County Committee. The initial cover sheets did not properly state the title of the party positions and was noticed as a defect subject to cure. The Commissioners' Committee determined that the multiple defects in the original cover sheets filed were validly cured in the Amended Cover Sheet. Their determination reflected the facts that:

- (1) the political party is clearly set forth on the Cover Sheet;
- (2) The use of the incorrect/incomplete sample heading on the Amended Cover Sheet (i.e. Public Office instead of Public Office/Party Position), is not a fatal defect. The Amended Cover Sheet is in substantial compliance with the Rules.

As the Appellate Division, 2nd Department held in <u>Siems v. Lite</u>, 307 AD2d 1016 (2003), "if there is substantial compliance and no evidence of confusion to either the voters or the board of elections there is no basis to invalidate petitions for the failure to comply with the cover sheet requirements". In this instance, there was no confusion to the voters or the Board of Elections with respect to the Amended Cover Sheet.

RECOMMENDATION:

The Office of the General Counsel recommends that the Commissioners find this Specification – **NOT AS STATED**.

SUMMARY OF RECOMMENDATIONS:

The Office of the General Counsel recommends that:

Specifications 1, 2, 3, and 5 of Specifications of Objection KG 30 be determined to be **NOT AS STATED**; and

Specification 4 be **DISMISSED** [Rule H8] or that the Commissioners have **NO JURISDICTION** [Rule H9].


