3 MR. SAVINO: Good afternoon,
4 commissioners. We are here today for a cover
5 sheet committee review. I appreciate the time
6 that you are taking to join us. There is only one
7 defect to present at this time. As you know, my
8 name is Rafael Savino, and Zoya Shpigelman, who
9 also works in the legal department has joined us.
10 As you may be aware, the cover sheet is supposed
11 to match the petition. The issue with respect to
12 this particular cover sheet involves a John E.
13 Sanchez, he's running for council member from the
14 15th Council District, Bronx County. The issue is
15 that the cover sheet lists an apartment number of
16 4E and if you take a look at the petition, the
17 apartment number is missing.

18 Now, our rules do say that a apartment
19 number is recommended but not required, but we
20 also have to make sure the cover sheets match the
21 petitions. A bipartisan staff reviewed these
22 documents and it was their opinion that it is a
23 defect and we agree with that opinion.

24 SECRETARY CAMILO: So I move that we

9 sheet where you would and I'll initial next to
10 it.

11 COMMISSIONER MARMORATO: Yes.

12 SECRETARY CAMILO: Yes.

13 MR. SAVINO: Okay. Well, that concludes
14 all the matters that we have to present today. Is
15 there a motion?

16 SECRETARY CAMILO: Motion -- go ahead,
17 Gino, sorry.

18 COMMISSIONER MARMORATO: I move to
19 adjourn today's meeting.

20 SECRETARY CAMILO: And I'll second that.
21 Thank you so much.

22 MR. SAVINO: It's unanimous. Thank you
23 both.


