4 commissioners. We're here for a cover sheet
5 committee review. It's January 14, 2021. And

9 presenting an amended cover sheet.

10 Originally, it had no apartment number
11 on the cover sheet, but it an apartment number on
12 the -- I'm sorry. It had an apartment number on
13 the cover sheet but it did not have any on the
14 independent nominating petition.

15 You know, an apartment number is
16 recommended but optional. But once it's on the
17 cover sheet, it should match the petition. So we
18 have an emended cover sheet that was submitted.

20 attached. It now matches the petitions and it has
21 also the language that I'm authorized to file
22 this cover sheet, amended cover sheet. It states
23 amended on the top, and it's our recommendation
24 that it complies with the board rules and it is a

17 concludes the cover sheet committee review and
18 again, I thank you for making yourselves
19 available and have a great day.

22 everyone. Have a good day.
