2 (The meeting commenced.)

3 MR. TOM SATTIE: Good morning, my name  
4 is Tom Sattie, ballot coordinator for the Board  
5 of Elections in the City of New York. With me is  
6 Michael Carmosino and Rayvon Weaver from the  
7 Candidate Records Unit. And we are doing the draw  
8 for civil court vacancies for the primary  
9 elections for 2021.

10 We will draw the boroughs, all five  
11 boroughs are in a basket with a piece of paper.  
12 We will pull out the -- we will pull out one by  
13 one the boroughs and in sequential order, we'll  
14 go the vacancy numbers. We will start with the  
15 first draw now.

16 The first borough selected is Bronx.  
17 Bronx has two civil court vacancies, so the  
18 vacancy numbers will be one and two for the  
19 Bronx. The next borough will be pulled out now.

20 MR. RAYVON WEAVER: Richmond County.

21 MR. SATTIE: Next is Richmond. Richmond  
22 has one civil court vacancy, so that will be  
23 vacancy number three in Richmond County. Next  
24 borough selected.

2 MR. MICHAEL CARMOSINO: Kings.

3 MR. SATTIE: Next is Kings County. Kings  
4 County has five vacancies. So there will be in  
5 Kings County, vacancy numbers four through eight.  
6 Next borough.

7 MR. WEAVER: Queens County.

8 MR. SATTIE: Next is Queens County.  
9 Queens County has four civil court vacancies so  
10 those vacancy numbers will be nine through 12,  
11 and lastly.

12 MR. CARMOSINO: New York.

13 MR. SATTIE: New York County. New York  
14 County will have vacancy numbers, there are seven  
15 vacancies in Manhattan, so that will be vacancy  
16 numbers 13 through 19. And that is the end of the  
17 draw for civil court vacancy numbers for the  
18 primary election of 2021. We will post to our  
19 website by the close of business today, a  
20 document that lists all of the civil court  
21 vacancies with the vacancy number listed for each  
22 vacancy. Thank you.
