MR. RAPHAEL SAVINO: Good afternoon, commissioners. We are here today on April 1, 2021 for a cover sheet review committee. We have the pleasure of joining us Commissioner Zaccone and Commissioner Pepe-Souvenir. And we're going to present items to you that we're submitting to the court with respect to cover sheets, amended cover sheets and the like. So without further ado, I will let Ms. Shpigelman present what she has for the Bronx.

MS. ZOYA SHPIGELMAN: Good afternoon, commissioners. The first matter we will be discussing is the name of a candidate is Mino Lora, the council member from the 11th Council District in Bronx County. And initially, we sent a letter of noncompliance on March 26, 2021. There was no identification number claimed on the cover sheet. We, she send in an amended cover sheet and the bipartisan team ruled that it was valid because now this new amended had the identification number that is required. So --

MR. SAVINO: As well as the heading

4	recommend that this be deemed a valid cure.
5	COMMISSIONER JOHN WM. ZACCONE: I agree,
6	it appears to be a valid cure, it meets all our
7	requirements.
8	COMMISSIONER RODNEY L. PEPE-SOUVENIR:
9	And I join Commissioner Zaccone. I agree.
10	MS. SHPIGELMAN: Thank you.
11	MR. SAVINO: And with your permission,
12	commissioners, as opposed to sending documents
13	back and forth, I will put your initials and also
14	put my initials on the document unless you'd
15	prefer otherwise.
16	COMMISSIONER PEPE-SOUVENIR: No, that's
17	fine.
18	COMMISSIONER ZACCONE: Yeah, you're
19	authorized to put my initials in the appropriate
20	locations.
21	COMMISSIONER PEPE-SOUVENIR: Mine as
22	well.
23	MS. SHPIGELMAN: Okay. Thank you,
24	commissioners. If I have your permission to go to

1 April 1, 2021 2 the next matter. 3 COMMISSIONER PEPE-SOUVENIR: Yes. 4 MS. SHPIGELMAN: Okay. The name of the 5 candidate is Sammy Ravelo, president of the borough of the Bronx of the city of New York. We 6 7 did sent a letter of noncompliance on March 29th to the candidate. The name of the candidate on 8 the cover sheet did not appear on the petition 9 10 initially. He sent another amended cover sheet 11 and the bipartisan team reviewed it and deemed it 12 to be a valid cure. Of course, this is within 13 your discretion, so we recommend that this be deemed a valid cure as well. 14 15 COMMISSIONER PEPE-SOUVENIR: I would 16 agree and I would allow us to agree that this is 17 a valid cure and you can place my initials to 18 that effect. 19 COMMISSIONER ZACCONE: [unintelligible] 20 [00:10:29] 21 MR. SAVINO: Oh, we can't hear you, 22 Commissioner Zaccone. 2.3 MS. SHPIGELMAN: We can't hear you, 24 Commissioner Zaccone.

COMMISSIONER ZACCONE: thank you, it appears, from the amended cover sheet that they have removed the volume where the name of the candidate was not included, and the cover sheet, the amended cover sheet meets all the requirements so I agree with the recommendation that this is a valid cure.

MS. SHPIGELMAN: Thank you very much.

And the only other matter, which was not sent to you because this was a pagination issue that was reviewed today, the candidate's name is Shaun Donovan, the party is Democratic. Their office and position is mayor of the city of New York. We sent him a letter and the team reviewed his pagination issue and he corrected it. So we recommend that this, you know, this is a valid cure as well. And the only issue that he had was the page after page 58 was listed as 56, so it was just a minor issue that was fixed with all the --

18	UNIDENTIFIED FEMALE: Yes. It's going to
19	be in the reverse order.
20	MR. SAVINO: That works.
21	COMMISSIONER PEPE-SOUVENIR: Thank you
22	so much, Commissioner Zaccone.
23	COMMISSIONER ZACCONE: Thank you.
24	UNIDENTIFIED FEMALE: Bear with me for

3	MR. SAVINO: There he is.

14	UNIDENTIFIED FEMALE: They were actually
15	listed on the original cover sheet as Queens,
16	Brooklyn / Queens. And he amended the cover sheet
17	stating Kings County for the Brooklyn, county of
18	Brooklyn.
19	COMMISSIONER PEPE-SOUVENIR: Mm-hmm.
20	MR. SAVINO: And it says it's amended.
21	UNIDENTIFIED FEMALE: And it says it's
22	amended, attached to the NCN and has the
23	certification language.
24	COMMISSIONER PEPE-SOUVENIR: Okay.

3	could be an attempted valid cure.
4	COMMISSIONER ZACCONE: Okay. Just give
5	me a second. I'm looking at all this. I see the
6	errors, I see the amended cover sheet and it
7	looks like it has the proper [unintelligible]
8	[00:14:54] and the signature and its listed as an
9	amended cover sheet, I agree, it's a valid cure.
10	UNIDENTIFIED FEMALE: Okay. Thank you,
11	commissioners.
12	COMMISSIONER PEPE-SOUVENIR: I join
13	Commissioner Zaccone.
14	UNIDENTIFIED FEMALE: Thank you.
15	COMMISSIONER ZACCONE: The next one is
16	Kim.
17	COMMISSIONER PEPE-SOUVENIR: Kim
18	Council, right.
19	COMMISSIONER ZACCONE: Yes. I'm just
20	downloading it now, so give me a second.
21	UNIDENTIFIED FEMALE: Okay. Here we go,
22	Kim Council. Kim Council, when we sent the NCN,
23	it was that the petition was never filed. The
24	issue was volume listed on the cover sheet not

2	filed. In her amended cover sheet, she only lists
3	four out of the five petitions, the one that she
4	had for petition KG2101254 she omitted on the
5	amended cover sheet. She now has filed for four
6	petitions, which she appears on.
7	COMMISSIONER ZACCONE: Okay. Thank you.
8	That's what I was going to ask you. I guess it's
9	your recommendation that this is a valid cure,
10	because that's what I see.
11	UNIDENTIFIED FEMALE: Yes, commissioner.
12	MR. SAVINO: That is correct,
13	commissioners.
14	COMMISSIONER PEPE-SOUVENIR: Right, the
15	four petitions.
16	COMMISSIONER ZACCONE: Very good. I
17	agree that it's a valid cure based on what I see
18	here.
19	UNIDENTIFIED FEMALE: Very good, thank
20	you, commissioners.
21	COMMISSIONER PEPE-SOUVENIR: Is the next
22	one Maxi Eugene?
23	MR. SAVINO: Which we will do that next
24	one.

3	Maxi Eugene. Maxi Eugene, it does not match.
4	Okay. Her original cover sheet stated that the
5	address was wrong. The address on the original
6	was 145 Linden Boulevard. She amended the cover
7	sheet and stated that her address is 143 Linden
8	Boulevard for KG816 is the petition number.
9	COMMISSIONER PEPE-SOUVENIR: Okay.
10	COMMISSIONER ZACCONE: And that matches
11	the petitions?
12	UNIDENTIFIED FEMALE: Yes, it does.
13	COMMISSIONER ZACCONE: Okay. So
14	MR. SAVINO: Our recommendation is it's
15	a valid cure.
16	UNIDENTIFIED FEMALE: Yes.
17	COMMISSIONER PEPE-SOUVENIR: Okay.
18	COMMISSIONER ZACCONE: I agree.
19	MR. SAVINO: Thank you, commissioners.
20	COMMISSIONER PEPE-SOUVENIR: I join the
21	other commissioner.
22	UNIDENTIFIED FEMALE: Thank you,
23	commissioners. Okay. We have
24	COMMISSIONER ZACCONE: Echevarria?

3	Yes, Echevarria, okay, with Echevarria, with Rick
4	Echevarria, the original cover sheet states that
5	he is on seven petitions. But when he amended his
6	cover sheet, he's only claiming the two, two of
7	the three [unintelligible] [00:19:03] petitions.
8	He's claiming NY2102123 and NY2102564.
9	MR. SAVINO: And he appears on those,
10	correct?
11	UNIDENTIFIED FEMALE: And he appears on
12	those petitions.
13	COMMISSIONER ZACCONE: Okay.
14	MR. SAVINO: And he did not appear on
15	the seven, on all of the seven that were first
16	listed.
17	COMMISSIONER ZACCONE: And all the other
18	information is correct thereon?
19	UNIDENTIFIED FEMALE: Yes.
20	COMMISSIONER ZACCONE: I'm assuming, the
21	amended cover sheet?
22	UNIDENTIFIED FEMALE: Yes.
23	COMMISSIONER ZACCONE: And the
24	certification language?

5	amended cover sheet with a signature, very good.

7	differently, but it is there.
8	UNIDENTIFIED FEMALE: Yeah.
9	COMMISSIONER ZACCONE: Yeah, no that
10	was, I was looking, I was concerned. Alright. I
11	assume the recommendation is this is a valid
12	cure, because that's what I think.
13	MR. SAVINO: That is correct.
14	COMMISSIONER PEPE-SOUVENIR: I agree.
15	UNIDENTIFIED FEMALE: Thank you,
16	commissioners.
17	COMMISSIONER ZACCONE: Scott Murphy
18	would be next?
19	UNIDENTIFIED FEMALE: Scott Murphy.
20	Scott Murphy, on his original cover sheet, he
21	stated that the volume was KN. He now amended it
22	and stated it was KG2100943.
23	MR. SAVINO: It has amended at the top,
24	attached the prior NCN or the cover sheet and has

3	certified to file the amended cover sheet.
4	COMMISSIONER ZACCONE: Okay. I see a
5	sticky on it that says cure due 4/1. I am
6	assuming it's good, because it looks like he
7	filed it on the 30th.
8	UNIDENTIFIED FEMALE: 30th, yes.
9	COMMISSIONER ZACCONE: Alright. So,
10	[unintelligible] [00:20:55]
11	MR. SAVINO: Yeah, the NCN was on the
12	29th.
13	COMMISSIONER ZACCONE: Yeah. I agree,
14	it's a valid cure.
15	COMMISSIONER PEPE-SOUVENIR: Yeah.
16	UNIDENTIFIED FEMALE: Thank you,
17	commissioners, and our last one, if you have
18	Vivia A. Morgan.
19	COMMISSIONER ZACCONE: I do.
20	UNIDENTIFIED FEMALE: Okay. With Ms.
21	Morgan, do you have her, on the cover sheet she
22	had her volume number as number one with no
23	petition number. So now in her amended cover
24	sheet, she put in her volume number and the

3	KG2101314 and she does appear on that petition.
4	COMMISSIONER ZACCONE: I'm reviewing it,
5	it says amended on the cover sheet and it has
6	certification and the appropriate signature, and
7	so I'm assuming this is a recommendation for a
8	valid cure?
9	MR. SAVINO: That is correct. I was
10	about to say Your Honor, but that is correct,
11	commissioners. Your Honor sounds nice anyway.
12	[laughter]
13	COMMISSIONER ZACCONE: I agree with the
14	recommendation.
15	COMMISSIONER PEPE-SOUVENIR: Mm-hmm.
16	UNIDENTIFIED FEMALE: Thank you,
17	commissioners. And then we have three more. I
18	don't know which order you received them in.
19	[CROSSTALK]
20	COMMISSIONER PEPE-SOUVENIR: Hold on.
21	Let me just get that, I didn't even get to review
22	that at all.
23	MR. SAVINO: Yeah, this is a late
24	addition, so we figured the more we get done, the

9	think.
10	UNIDENTIFIED FEMALE: Yes.
11	MR. SAVINO: Yeah, Manhattan is on deck,
12	awaiting eagerly outside of the
13	COMMISSIONER PEPE-SOUVENIR: Okay. Let
14	me just go back. I'm sorry.
15	COMMISSIONER ZACCONE: Not a problem.
16	This one was what came in at 3:08.
17	COMMISSIONER PEPE-SOUVENIR: Alright.
18	Hold on. Oh, get out of here then. 3:08, I don't
19	think I got that. I got 2:49 and the next one I
20	get is 3:16. I didn't get the 3:08.
21	COMMISSIONER ZACCONE: I'll send it to
22	you now, commissioner.
23	COMMISSIONER PEPE-SOUVENIR: Yes,
24	please, thank you. Yeah, the next set I have is

14	COMMISSIONER PEPE-SOUVENIR: Okay.
15	UNIDENTIFIED FEMALE: Daniel Christmann,
16	COMMISSIONER PEPE-SOUVENIR: I didn't
17	get it yet.
18	COMMISSIONER ZACCONE: I'll just scoot
19	it along.
20	COMMISSIONER PEPE-SOUVENIR: Was it a
21	big document?
22	COMMISSIONER ZACCONE: Apparently. Oh,
23	it went to you at gmail.com.
24	COMMISSIONER PEPE-SOUVENIR: Oh, you

2	sent it to my gmail account, okay.
3	COMMISSIONER ZACCONE: Yeah, that's the
4	only address I have for you.
5	COMMISSIONER PEPE-SOUVENIR: Oh, sorry.

8	COMMISSIONER ZACCONE: Mr. Savino? I
9	know you guys are swamped there, but it would be
10	really helpful to us in the future if we can get
11	these a little bit earlier.
12	MR. SAVINO: I understand completely.
13	COMMISSIONER ZACCONE: And then, you
14	know, hopefully it won't be too many more this
15	year. [laughter]
16	COMMISSIONER PEPE-SOUVENIR: Sorry, you
17	have to just bear with me. I'm going to another
18	computer.
19	COMMISSIONER PEPE-SOUVENIR: If you
20	wish, I can forward to any address you like.
21	COMMISSIONER PEPE-SOUVENIR: Would you
22	mind just forwarding it to my BOE account?
23	MR. SAVINO: Certainly, I would not
24	mind.

3	don't mind.
4	COMMISSIONER ZACCONE: I'm sorry about
5	that. That's the only one I had for you.
6	COMMISSIONER PEPE-SOUVENIR: No, that's
7	all right, don't even worry about it.
8	MR. SAVINO: Okay. I sent it to the BOE
9	account, I do have other emails for you, but that
10	is the one I sent it to.
11	COMMISSIONER PEPE-SOUVENIR: Okay.
12	MR. SAVINO: To your official account.
13	COMMISSIONER PEPE-SOUVENIR: Cool. You
14	know what, I can do this. I'm ready. Daniel
15	Christmann.
16	MR. SAVINO: Christmann, okay.
17	UNIDENTIFIED FEMALE: Okay,
18	commissioners, if you're ready.
19	COMMISSIONER PEPE-SOUVENIR: I am ready.
20	UNIDENTIFIED FEMALE: Very good, thank
21	you. The issue was the letter that we had sent,
22	that the candidate did not appear on petition
23	KG2100149, which he does not. He amended his
24	cover sheet, stating that he appears on KG2101083

which the candidate does appear but he did not send an amended cover sheet. He did not file an amended cover sheet with us, nor the language on the cover sheet.

COMMISSIONER ZACCONE: Okay. Just to be clear, for myself, I'm looking at the second document he filed on the 30th, which does not say amended, does not say cover sheet, just says

Democratic Party, I see the identification number you spoke of, does not have the certification language required and does have some sort of signature there, but we don't know who it is for sure, we assume it's Christmann. I don't know what your recommendation is, but I'm of the opinion that this is an invalid cure.

COMMISSIONER PEPE-SOUVENIR: Right.

MR. SAVINO: Yes, that would be our opinion. As you pointed out, it, you know, it should say amended cover sheet, amended is one of the key words, but it doesn't even say cover sheet. So it does not say amended cover sheet and it does not have the required certification language.

3	not a valid cure.
4	MR. SAVINO: Correct. That is our
5	recommendation.
6	COMMISSIONER PEPE-SOUVENIR: Yeah. And,
7	as you indicated, the other identification number
8	is not attached to Mr. Christmann, correct.
9	MR. SAVINO: The first cover sheet, the
10	number he put down, he doesn't appear on, but on
11	the second cover sheet he does, however, he
12	didn't comply with the rules with respect to
13	amended cover sheets.
14	COMMISSIONER PEPE-SOUVENIR: Then it's
15	invalid. I would agree with Commissioner Zaccone.
16	MR. SAVINO: Alright. Thank you,
17	commissioners.
18	UNIDENTIFIED FEMALE: Thank you,
19	commissioners.
20	COMMISSIONER ZACCONE: Is the next one
21	Frankel, Eric Frankel?
22	UNIDENTIFIED FEMALE: Mr. Frankel, okay.
23	Mr. Frankel, yeah, right, Mr. Frankel, okay, on
24	this one for Mr. Frankel he did an amended cover

sheet stating that he is on petition KG2100412,
411 and 413. But on 411 and 413 the position
states that it is the 38th Council. On 412, it
still states that the petition for the office is
the 20th Council District for Kings County and
he's still claiming that petition number.
COMMISSIONER ZACCONE: And we've
received no other documentation or anything on
this?
COMMISSIONER PEPE-SOUVENIR: Right.
COMMISSIONER ZACCONE: I'm asking.
UNIDENTIFIED FEMALE: Yeah, because the
amended, that's the amended, and that's for the
older
MR. SAVINO: Right. He's basically
claiming a petition number that he appears on for
a different candidacy, correct?
UNIDENTIFIED FEMALE: That's 38, so
here, 12
COMMISSIONER ZACCONE: Okay. So you're
saying that petition number 412, he
MR. SAVINO: Does not match.
COMMISSIONER ZACCONE: appears on it

2	but it does not match the public office?
3	COMMISSIONER PEPE-SOUVENIR: Yeah.
4	UNIDENTIFIED FEMALE: Correct.
5	MR. SAVINO: It doesn't right.
6	COMMISSIONER PEPE-SOUVENIR: Right.
7	MR. SAVINO: [unintelligible] [00:31:45]
8	has to be running for on the cover sheet.
9	COMMISSIONER ZACCONE: Alright. And
10	again, I'm asking the question, we've received no
11	other documentation on this?
12	MR. SAVINO: Not that I'm aware of in
13	terms of [unintelligible] [00:31:58].
14	COMMISSIONER ZACCONE: Alright. Then
15	unfortunately, I believe it's an invalid cure. I
16	also note that the supposedly amended cover sheet
17	does not have the certification language that we
18	require.
19	MR. SAVINO: That is correct.
20	COMMISSIONER ZACCONE: So therefore,
21	based on the various reasons cited, I believe
22	it's an invalid cure.
23	COMMISSIONER PEPE-SOUVENIR: Invalid
24	cure.
